Terms and Conditions

1. Entry is Free.
2. For the purposes of the Competition, "busking" is defined as playing a musical instrument and/or singing.
3. Busking can be a solo or group performance.
4. Buskers are to perform at permit location for the specified time with such details to be given to the Busker prior to competition start time and at least one song is to be performed by the Busker at the Performance Stage located in Dick Caplick Park at the time provided to the Busker by the Facilitator.
5. Guitars – Electric or Acoustic (battery amplification only).
6. The Facilitator reserves the right to accept, reject or refuse an entry at any time.
7. Buskers must follow all directions by the Facilitator including performing in accordance with the busking permit.
8. Buskers will be rostered to perform at different locations along Memorial Drive Eumundi and at the performance stage.
9. Buskers will be permitted to busk in one location for a limited time. Buskers shall only operate at the designated site for their registered times and at the performance tent at their designated time.
10. To be eligible to win, the Busker must also perform at the Slam'n'Busk in the Imperial between 2-5pm (amplification provided at the Slam'n'Busk).
11. Buskers' performances must be safe and in no way endanger any person or property.
12. Performance equipment, instruments and associated belongings shall be positioned to all safe access for pedestrians at all times
13. Buskers must abide by the terms and conditions of the busking permit attached.
14. The finalist/s will be chosen by the judge panel located at the performance tent on 26 August 2017 and the winners will be chosen at the Slam'n'Busk event in the Busker.
15. The decision as to the winner/s is final and no correspondence will be entered into.
16. The winner/s will be notified on the day.
17. The Competition prizes are 2 paid gigs at the Imperial Hotel to the value of \$750 and an option to perform at a paid gig at the Tastes of Eumundi on Sunday 27 August between 10am and 2pm.
18. Buskers agree to participate in any promotional, marketing and publicity activities by the Facilitator in relation to the Competition.
19. Buskers also agree that the Facilitator may take any photographs of them taken at the Busk Off or Slam'n' Busk and such photographs can be used in any promotional, marketing and publicity purposes of the Facilitator and in any media without notice and without any fee being paid to them, and relinquish all moral rights to same.
20. Buskers represent and warrant they are knowledgeable about the copyright laws of Australia as applicable to their performance.
21. Buskers voluntarily undertake any risks associated with the Competition.
22. The Facilitator, its employees, agents and officers do not accept any responsibility for any liability for damage, loss or injury, however caused, that they may suffer as a result of arising from a breach of these terms and conditions or their participation in the Competition.
23. Buskers acknowledge and agree that the Facilitator and its employees, agents and officers may plead this waiver and indemnity as a bar to any proceedings they may commence against all or any of them.
24. Buskers agree to indemnify and keep indemnified the Facilitator, its employees, agents and officers against any liability, claim, demand, cost or damage they may incur as a result of or arising from a breach of these terms and conditions or their participation in the Competition.
